

Duties and Responsibilities:

- 1. Responsible for the technical studies, construction and supervision of the development projects of the Company and assist the Managing Director for negotiating project financing issues with development partners.
- 2. To pursue and maintain liaison with the Ministry of Land, local public representatives regarding approval of land acquisition, ascertaining land compensation amounts, etc. and related works with concerned office.
- 3. To pursue and maintain liaison with relevant ministry for compensation of crop, paddy, tree, or any other things which will be damaged during construction work.
- 4. To monitor and supervise project's EPC works, review of technical specifications and drawings, approving, and supervising the construction works.
- 5. To pursue and maintain liaison with PGCB and BPDB regarding project works and any other related issues.
- 6. To coordinate among the projects of the company and supervise the activities of the Project Directors.
- 7. To perform any other duties assigned from the competent authority of the Company from time to time.
- 8. To monitor the preparation of Project Completion Report (PCR) of each completed project.

Required Qualification and Experience:

- a) At least B.Sc. in Electrical/Mechanical Engineering from any recognized university/college/institute.
- b) No third Division/Class at any stage of the academic career shall be acceptable. Candidates passed in the grading system must possess at least a GPA 3.0 on a scale of 5.0 and a CGPA 2.5 on a scale of 4.0.
- c) At least 5 (five) years of working experience in the senior managerial position (SE & above) in the large power utilities, preferably in generation related projects.
